I will and bequeath to my son Vincent Myers for his support during his natural life all that real estate I do possess of, being and lying in Emmittsburg District, Frederick County, Md, in part, the other part lying and being in Liberty Township, Adams County, and State of Pennsylvania, along with all my household and kitchen furniture, in short all the property I do possess of Real, Personal and Mixed, for the sole use of said Vincent Myers, the
