This Indenture, made this fifteenth day of June Anno Domini, Eighteen hundred and fifty two, by and between the Weaver Manufacturing Company, incorporated by an act of the General Assembly of Maryland, of the one part, and Capt Hezekiah Bolter of Washington County, and State of Maryland, of the other part - Witnesseth, that for an in consideration of the sum of Two hundred and seventy seven Dollars, lawful money of the United States) to the said Company in hand paid, at and before the sealing and delivery of these presents, the receipt whereof from the said Hezekiah Bolter they do hereby acknowledge and bind themselves to be therewith fully satisfied contented and paid - They the said Company have granted, bargained, sold, aliened, enfeoffed, released and confirmed - and by these presents do grant, bargain, sell, alien, enfeoff, release and confirm unto the said Capt. Hezekiah Bolter, his heirs and assigns forever. All the following parts and parcels of land lying and being in the Town, Weaverston Frederick County, State of Maryland to wit: - Lots No. 12 & 13. in Section No. 25. and Lots No 1. and 30. in Section 26. and Lots No 9. & 10 in Section in No. 35 and Lots No. 16. & 17. in section No. 50. and Lots No. 16 & 17 in Section No
