The Bill of Complaint of John W. Senebaugh and Amanda Senebaugh of Frederick County, State of Maryland, shows that a certain Joseph Senebaugh late of Frederick County, State of Maryland, died unmarried, intestate and without issue on or about the Eighteenth day of July in the year Eighteen hundred and twenty seven, seized and possessed in fee simple, of all those parts of tracts of Land, situate in Frederick County, State of Maryland, called "Third time for Asking", "Snyder's Addition", and "Forrest's Purchase", containing thirty one acres of Land, more or less, and also described in the deed from John Senebaugh, and wife, to said Joseph Senebaugh by deed a certified copy of which deed is herewith Exhibited marked Exhibit No. 1, which with all other Exhibits hereinafter produced - Your Complainants pray may be taken as part of this their Bill of Complaint.

Your Complainants further states that said Joseph Senebaugh at the time of his death, did seized and possessed in fee of another part of a tract of Land situate in said County and State, containing Eighteen acres, two rods and two inches of Land, described in a deed from Daniel Warrenfels, Trustee to said Joseph Senebaugh, a certified copy of which deed is herewith Exhibited marked Exhibit No. 2.

Your Complainants, states that said Joseph Senebaugh at his death left a brother Jacob Senebaugh, and the following children of a deceased brother, and a deceased sister his heirs at law to wit: George A. Senebaugh one of your Complainants living children of John Senebaugh deceased, a brother of said Joseph Senebaugh, and who died before the said Joseph Senebaugh, and the following children of Catharine Smith wife of Christian Smith a sister of said Joseph Senebaugh, and who died before the said Joseph Senebaugh to wit: Peter Smith, Levi Smith, Martin H.
