At the request of David Justice the following
Deed is recorded 30th, November 1829.

This indenture, made this seventeenth day of
October, eighteen hundred and twenty nine, between Andrew Lugenbuel
of Frederick County, State of Maryland, of the one part, David Justice
of the same place of the other part, Witnesseth, that the said Andrew
Lugenbuel for and in consideration of the sum of Thirties Hundred
and fifty dollars current money of the United State to him in hand
paid by the said David Justice before the sealing and delivery of
these presents the receipt whereof he said Andrew Lugenbuel doth
hereby acknowledge hath granted, bargained, sold, aliened, conveyed
and confirmed and by these presents doth grant, bargain, sell, alien,
convey and confirm unto the said David Justice his heirs and
assigns all and every part of that tract or parcel of land lying
and being in the County and State of aforesaid, being part of the
Resurvey on Woods Lot, Beginning at the end of twenty seven
perches on the first line Dappingtons part of said Land and running
thence North eighty nine and a half degrees east, One hundred and
eleven perches, South thirty six perches, South eighty nine and an
half degrees West One hundred and eleven perches, then North
thirty six perches to the Beginning containing twenty five acres
of Land more or less. Together with all and singular the
buildings, improvements, woods, ways, waters, water-course, rights,
liberties, privileges, Hereditaments and appurtenances whatsoever
thereunto belonging or in any wise appertaining, and the reversions
and remainders, rents, issues and profits thereof and all estate, right,
title and interest whatsoever of him, the said Andrew Lugenbuel
both at law and in Equity of in to and out of the said
tract or parcel of land and premises hereby bargained and
sold or meant, mentioned or intended hereby so to be and
every or any part and parcel thereof. To Have and to Hold,
the said tract or parcel of land, so as aforesaid described.
Together with all and singular other the premises hereby bar-
gained and sold or meant, mentioned or intended hereby
so to be and every of their appurtenances unto the said
David Justice, his heirs and assigns forever, and to and for
no other use intent or purpose whatsoever.
