Keilley their Mother, reverted to said children with the exception of the interest of Thos Keilley, but has not been conveyed by said Wellington Hammond Trustee to said Children that Thomas Keilley in the year 1873 applied for the benefit of the Insult Writ. law of Maryland in pursuance of the 48th Art of the Maryland Code of Public General Laws and that Thomas M. Wolfe was appointed Trustee, and the said Thomas Keilley conveyed his interest in said lands to said Trustee. It is therefore this 22nd day of August A.D. 1878, adjudged and ordered that the complainant by causing a copy of this order to be inserted in some newspaper published in Frederick County, once a week for four successive weeks before the 28th day of September 1878 give notice to the said absent defendant of the object and substance of this Bill; And cause him to appear in this Court in person or by Solicitor on or before the first day of January, 1879, to answer the premises and show cause if any, he has why a decree ought not to pass as prayed
