

Ninety one and a half acres and twenty five perches of Land
 and described in the Survey and Plat, made by George H. Dudderar on
 the 19th. of October 1869:— I give devise and bequeath to my
 Brother Dawson V. Hammond all the rest and residue of my Home
 Farm in Trust, to permit my niece Louisa Griffiths Wife of John
 Griffiths to occupy the same Trust to pay over to her during her life for
 her sole separate and exclusive use free from the Marital rights of her
 said Husband the marital rights of her said Husband the rents
 issues and profits thereof and after her death. I give and devise
 said lands to her children then living and to the issue of any of her
 Children who may then be dead to be divided per Stirpes. But in case
 my niece Louisa Griffiths shall pledge or mortgage or charge said life
 Estate or the rents issues and profits thereof then such devise and
 bequest in her behalf shall cease be void and forfeited and in
 such case I give and bequeath the same to her Children and the
 issue of any Child who may then be dead to be divided per Stirpes
 I give and devise to my Nephew Lepton Hammond the Farm on which
 he resides, I give and devise to my Nephew Burgess Hammond the
 Farm on which he resides excepting and reserving the two Wood Lots
 which I purchased from Delashmuth:— I give and devise to my
 Nephew William Hammond the Farm on which he resides charged
 with the payment of one Thousand dollars to my Executor hereinafter
 named for the benefit of my estate I give and devise to my niece Charlotte
 C. Hood the Farm on which she resides charged with the payment of
 Five hundred dollars to be paid to my Executor for the benefit of
 my Estate. I will and direct that my niece Mary Hammond and
 my niece Molly Griffiths shall have a Home on the property devised
 to my niece Louisa Griffiths during her life and after her death
 to her children during their respective lives or as long as they or she shall
 think proper to reside on said premises, and to be maintained and
 supported out of the proceeds of said property as long as they respectively
 live thereon except clothing said Legatees. I will and direct
 that all the rest and residue of my estate Real Personal and mixed
 whosoever Situate shall be sold by my Executor hereinafter named at Public
 or Private Sale and upon such terms as he may deem most expedient
 upon which Proceeds of Sale of Real and Personal Estate, I charge
 the payment of my general Expenses and Just debts. And after
 payment of debts and general Expenses, I give and bequeath
 all the rest and residue of my estate to my Executor hereinafter
 named in trust to appropriate such residue according to instruc-
 tions which I may give him And in case I should fail to give
 such instructions then in trust to distribute such residue among
 such of my relations in such sums and at such times as my
 said Executor may in his absolute discretion appoint. And lastly
 I constitute and appoint my Brother Dawson V. Hammond
 to be sole Executor of this my last will and testament hereby
 revoking all former Wills by me made. In Witness whereof
