

Answer: The estimate I make of said lands owing to the depreciation of Real Estate & the condition of the farms is as follows Viz:

 280 acres situated in the Barren of Carroll Co. Md. & in possession
 of Gustavus Cwings and Belle Hammond about \$1,400 -
 making an aggregate of about \$19,100. -

16th Int: - Have you as grantee of said Thomas Hammond under
 the deed aforesaid made any conveyance of any part of the
 land conveyed by said Deed & if yea to whom? For what consideration?

Answer: I have deeded all my interest subject to the payment of the
 debts of Col. Hammond to Burgess Hammond the lands
 described in "Exhibit No 6." filed in this cause for the consideration
 of five dollars which consideration is not paid and never was
 intended to be paid.

17th Int: - Does any person other than yourself claim the
 property conveyed to you by the said Thomas Hammond
 by "Exhibit No 5." and if yea whom?

Answer: - Yea by the parties whom I have named as in the possession
 of the said lands except Gustavus Cwings and Belle
 Hammond & as devisee of the Will of said Thomas Hammond filed in this
 cause as "Exhibit No 4."

18th Int: - You said in answer to a previous Interrogatory that
 Col. Hammond was dead - was he married or unmarried
 at the time of his death?

Answer: - He was unmarried and died without leaving issue.

19th Int: - Did he leave brothers and sisters of the whole blood
 & children of deceased brothers and sisters of the whole
 blood and if yea state their names, ages and present places of
 residences as far as you know?

Answer: - He left one sister of the whole blood named Juliet
 Angell who is an adult & resides in Liberty District
 Frederick County, Md. - Louisa Griffith Npton J. Hammond Burgess
 Hammond William P. Hammond Charlotte, Co. married to Basil Wood
 Richard T. Hammond Nathan Hammond & Carroll Hammond all
 adults & children of Nathan Hammond a brother of said Thomas
 Hammond who died before the decease of the said Thomas Hammond
 died: - Npton J. Hammond son of Npton Hammond deceased
 & brother Rezin Hammond who died before the said Thomas Hammond
 left children adults who are unknown to this deponent & who reside
 out of the State of Maryland A brother John Hammond who died
 before the decease of the said Thomas Hammond the name of whose
 children are unknown to this deponent but who reside in the
