

& work done for him besides your Petitioner was found as security
 for said Dennis Leaking upon a note payable to Wm Foyle of Md. for
 the sum of Fifty Dollars still due & unpaid with interest from
 the 23 day of Sept. 1873. less \$13. paid Dec 31 1873 & \$5⁰⁰ paid
 April 1st 1874. and the said Dennis Leaking was also indebted to
 Dr. W. H. Wagner in the sum of Fifty & ³³/₁₀₀ Dollars by his promissory
 note dated Feb 8th 1876 upon which Thos. Leaking was surety, & which
 has been paid by your Petitioner Joshua Albaugh Trustee for the heirs
 of said Dennis Leaking & said note assigned to him by said Wm H Wagner
 that all of said claims are still due & unpaid & will more fully appear
 by said notes & accounts filed in No. 4168 Equity in your Honorable
 Court & prayed to be taken as part of this Petition. - your Petitioner
 would further show that said Dennis Leaking did seized & possessed
 of certain Real Estate situated in Frederick County and that on the
 5th day of June 1876. a bill of complaint was filed in your Honorable
 Court by Saml B B Ecker & Others on behalf of the heirs at law of
 said Dennis Leaking for the sale of said real estate & your Honors
 appointed Geo Ritchie Esq Trustee to make such sale which sale has
 been duly made & reported to & ratified by your Honorable Court and
 the purchase money has been paid or secured to said Trustee all of

 day why the said proceeds of sale of Real estate should not be applied
