I give, devise and bequeath unto my beloved wife Mary E. Primmer all my Estate of Realty and nature whatsoever and wheresoever, to her the said Mary E. Primmer her heirs and assigns absolutely and subject to her disposal by Deed or giftment or by Will
And I do hereby constitute and appoint my said wife Mary E. to be the Executrix of this my last Will and Testament, renouncing and annulling all former wills by me heretofore made, ratifying and confirming this and none other, to be my last Will and Testament
In testimony whereof I hereunto set my hand and seal this second day of December in the year of our Lord one thousand eight hundred
