 and wherever situated of and the said George R. Dennis except  
 such Property as by the Laws of Maryland is exempt from execu-  
 tion - together with all and singular, all and every property, right,  
 interest and estate, whether Real, Personal or mixed of any and  
 every kind whatever, and wherever the same may be situated,  
 of and the said George R. Dennis - to have, hold and take the same  
 upon trust, that he the said William P. Maulsley, Jr. do and
