Williams wife of Syddnah Williams of said County and State, the said sum being her own separate money, we the said Otho W. Trundle and Sarah Trundle his wife, do grant unto the said Mary C. Williams as her separate property all those four Lots or parcels of ground situate lying & being in the village of Point of Rocks in the County of Frederick and State of Maryland aforesaid known and designated as Lot No. One (1) Number two (2) Number four (4) and Number five (5) on the Plat of the Point of Rocks as originally laid out Charles Johnson the owner thereof, together with the buildings improvements, ways, waters, water-courses privileges advantages and appurtenances thereto belonging in anywise appertaining, in fee simple.
