Said sales shall return their proceeds to this Court for its ratification and approval - and the purchase money received and arising from the sale of the mill properties shall be applied in payment of the mortgaged debt and interest of the said Thomas A Harmon, in the first place - and the residue if any shall together with the proceeds of the other sales and collection of debts due - shall be applied by said receivers under the direction of this Court to the payment of the debts of the said firm of J. E. Cartzendafer & Pro. Equally without any preference or priority whatever, the costs and expenses of these proceedings, and commissions to the said Receivers hereafter to be allowed being first deducted
