Ross of Frederick County, State of Maryland in trust for the benefit of his creditors as hereinafter named, And the said Rebecca Baker wife of the said Henry Baker agreeing to join in the execution of said Deed of Trust with her said Husband in consideration of being allowed the sum of six hundred dollars
