To 5th Sub. - He left a widow Her name is Elizabeth Hentz. She is about fifty-five years of age, and has good health.

To 6th Sub. - Reuben Hentz left children summing him as follows. He left a daughter Missouri who is married and the name of whose husband is Winfield Punchart She is over twenty-one years of age and resides in Frederick County State of Maryland
