This Indenture made this 16th day of January
in the year of our Lord One thousand eight hundred and twenty four
between Thomas F. Marlow and Elizabeth Marlow his wife of Frederick
County and State of Maryland of the one part, and Thomas F. Marlow
of Frederick County and State of Virginia of the other part Witnesseth
that the said Thomas F. Marlow and Elizabeth his wife do and intend
in view of the natural love and affection the bear towards their son Thomas
F. Marlow - as also for the further comfort and use of the sum of Five dollars cur-
rent money to them in hand paid by the said Thomas F. Marlow before the
writing and delivery of these presents, the receipt whereof they do hereby acknow-
ledge as before account, execute and discharge to and to the said Thomas F. Mar-
low his heirs and assigns all that certain tract or parcel of land situate in Frederick
County and State of Maryland which was heretofore devised
by Thomas F. Marlow the father to Elizabeth Marlow being part of a tract of
land called "Henry's Bay" and part of a tract called "One light-
house" her and her heirs and assigns in the year One thousand and
eight hundred and twenty one together with all and singular the appurtenances
thereunto belonging, and every part and parcel thereof; to have and to hold
the aforesaid tract or parcels of land with the appurtenances thereunto
belonging unto the said Thomas F. Marlow his heirs and assigns forever and
to and for no other use intent or purpose whatsoever, and the said Thomas
F. Marlow & Elizabeth Marlow for the uses their heirs Executors and ad-
ministrators doth covenant grant promise and give to and with the
said Thomas F. Marlow his heirs Executors Administrators and assigns
that they the said Thomas F. Marlow & Elizabeth his wife and their heirs
the aforesaid tract or parcels of land and premises hereby granted bargained
and sold and every part and parcel thereof with the appurtenances thereunto
belonging to have the said Thomas F. Marlow his heirs and assigns against
them the said Thomas F. Marlow and Elizabeth Marlow and heirs and against all
and every person or persons whatsoever claiming any right title or interest in
and to the same or any part thereof shall and will hereafter warrant and
forever defend by these presents.

Marlow both hereunto subscribed their names and affixed their seals
the day and year herein before written.
