Eighteen hundred and eighty, by me John W. Daughman, of Frederick County, in the State of Maryland, Witnesseth, that in consideration of the sum Five hundred and fifty dollars, I the said John W. Daughman do grant in fee simple, unto William G. Youngling of said County and State, all of that parcel of Land situate lying and being in the County of Frederick, and State of Maryland, being part of a tract of Land called "New Bremen" containing Eighty nine acres of Land, more or less, and which is described by metes and bounds, courses and distances in a deed from Joseph M. Cromwell to Roger Johnson, dated the tenth day of August in the year Eighteen hundred and nine, and recorded in the Land Records of Frederick County aforesaid, in Liber N. R. No 316 folios 398; and being therein designated, as Lot No. 12, as by reference to said deed and records will fully and at large appear, and being the same parcel of Land which the said John W. Daughman obtained from Joseph N. Cheswell, Executor of John C. Osborne, deceased, by deed bearing even date herewith, and intended to be recorded in the Land records of Frederick County aforesaid, simultaneously with these presents.

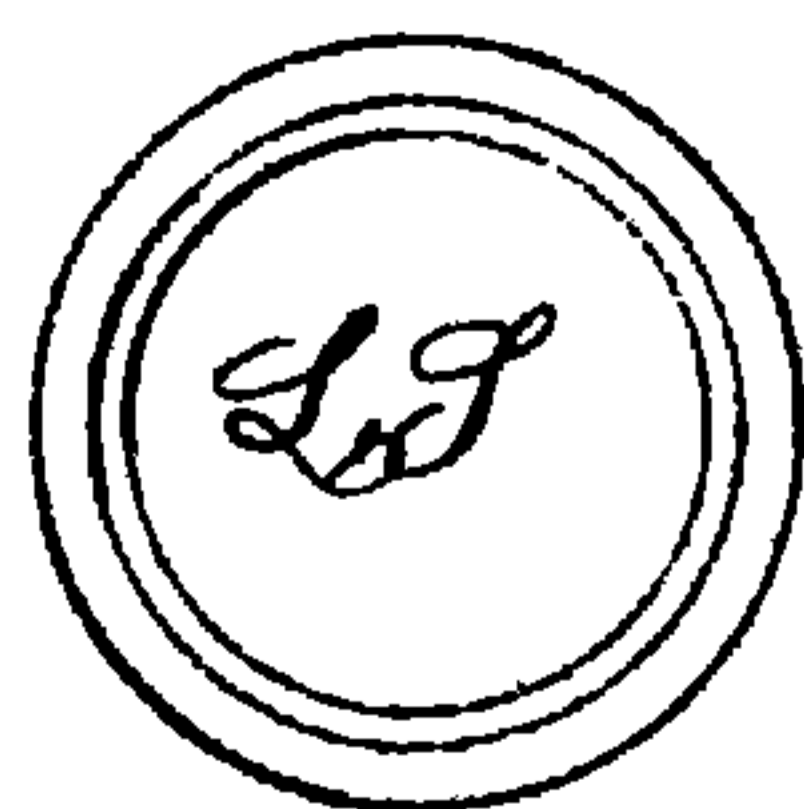
