Interrogatories to be propounded to witnesses to be produced on the part of the Complainant in the above case.

- 1st. - Do you know the parties to this suit and if yes, how long have you known them?
- 2d. - Did you know Aba. Shook late of Frederick County - Is he living or dead? If dead when and where did he die?
- 3d. - Did you know the hand writing of said Aba. Shook? If yes, look at the paper now shown you marked Exhibit No. 1, and state whether or not the signature there purporting to be the signature of Aba. Shook is in the own proper handwriting of said Aba. Shook?
- 4th. - Was the said Aba. Shook indebted to the Complainant at the time of his death, and if yes in what amount, and how was such indebtedness evidenced? And has such indebtedness ever been paid?
