of Frederick County, in the State of Maryland, Witnesseth that in consideration
of Three hundred and five Dollars, the said A. W. Burkhardt doth grant and convey
unto Nathan O Neighbors One undivided half of the said Burkhardt's interest of in
and to a certain tract of parcel of Land situate and being in Mt Pleasant District in
the County and State aforesaid, called "Addams's Choice" & containing 139 Acres of
land more or less, it being the same tract of land which was purchased by the said Burk-
hardt at Sheriff's Sale, and which was conveyed to the said Burkhardt by N. O. Neighbors
(Sheriff of Frederick County, Md) by deed bearing date June 16th 1869, and recorded
in Liber C. M. No. 3 Folio No. 624 one of the Land Records of Frederick County, as by ref-
erence thereto for further particulars, courses, distances &c will more fully appear.

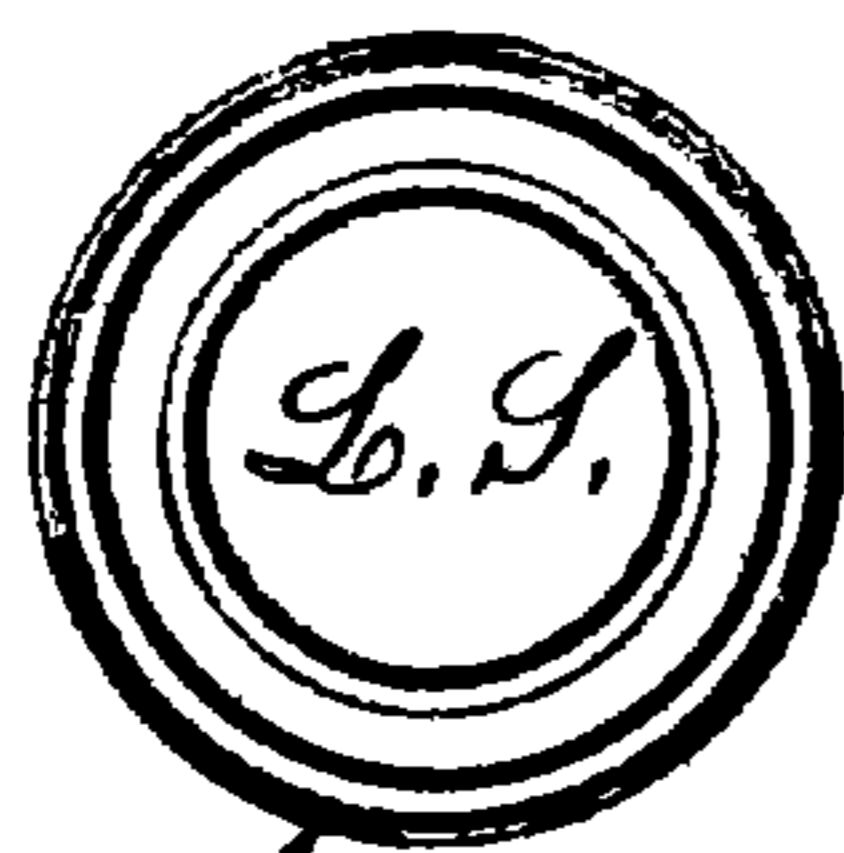
