as his children, and heirs, at law Elizabeth C. Miller, Caroline Lydia, Margaret A.,
 Amanda Virginia, Lavina E. J. and John Simon Miller, all of whom are minors
 under 21 years of age, and together with the said Sarah Miller reside in Frederick County,
 And your Orator further charges that the said Sarah Miller widow of the said Simon
 Miller as aforesaid has, without right and against the rights and interest of the said Ora-
 tor, converted to her own use, and sold, and appropriated the proceeds of such sale of the
 horses mentioned in Exhibit "A" and of many of the other articles of Personal Property
 described therein which are not specifically known to your Orator, and which including
 said horses, are to the value of three hundred dollars. And your Orator suggests and
 will ask your Honor that your Honor shall set off against the said Sarah Miller the value of
 the articles of personal property which are by said Exhibit "A" mortgaged to secure
 your Orator in his said debt in any allotment which may be made to the said Sa-
 rah Miller on account of her right of dower. And your Orator charges that the Real
 estate mentioned in Exhibit "A" cannot be divided to any advantage, so as to set
 off the honorable interest of said Sarah Miller, and that the interest of all parties in
 interest require that the lands should be sold, and the interests of the parties as particu-
 larly set out to the proceeds of such sale in the manner, and to the extent provided by Law.

And your Orator further charges that said Sarah Miller widow of said
 Simon Miller has no other property except her right of dower in the lands in Exhibit
 A mentioned, which can be made available to her creditors.

To the end therefore that the said Sarah Miller, Caroline L. Elizabeth, Mar-
 garet A. Virginia M. H. Elina S. D. and John Simon E. C. Miller, may answer
 the premises as fully and particularly as if they were herein again repeated and
 they were thereunto specially interrogated, and that the premises aforesaid may be
 sold for payment of your Orator's claim with interest as aforesaid and that your Orator
 may have such further or other relief, as his case may require.

May it please your Honor to grant unto your Orator the writ of Subpoena against
 the said Sarah Miller, Margaret A. Miller, Elizabeth Miller, Caroline Lydia
 Miller, Virginia M. H. Miller, Elina S. D. Miller and John Simon E. C. Miller
 commanding them and each of them to appear in this Court at some certain day
 to be named to answer the premises, and abide by and perform such decree as may
 be passed therein and as in duty bound &c
