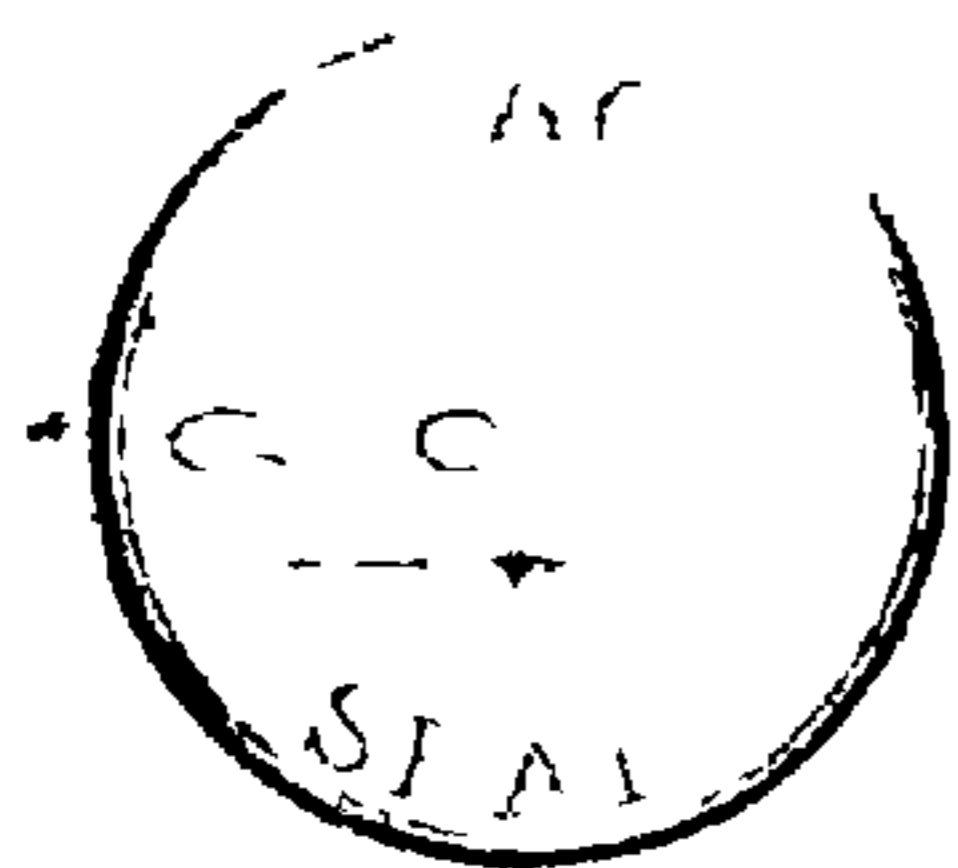

To all people to whom these presents shall come, Greeting. Know ye that we Burgess S. Clary & Sarah Clary his wife of Frederick County, in the State of Maryland for the consideration of Twenty seven and a half dollars received to our full satisfaction of Robert Nelson of the County & State aforesaid, do give, grant bargain sell and confirm to the said Robert Nelson, his heirs and assigns forever the following described parcel of land lying on Israels Creek in the County aforesaid, & being part of Monocacy Manor. Beginning at the end of the tenth line of that part of said land heretofore conveyed by us the grantors above named to Gideon M. Crumtough and running thence with the Eleventh line thence of S 16th W 19th to a stone planted in the middle of the road, then with a straight line along the middle of the road until it intersects the outline of the said Robert Nelson's land then with said line to the Beginning aforesaid including all the land lying on the North of the said Road and between the aforesaid
