And, which said Exhibit your Complainant prays may be taken and considered as part of this their Bill of Complaint, the same as if set forth in words and figures.

Your Complainants further state that the said Daniel Straffer died in the month of February, in the year 1882, having first executed his last Will and Testament dated May 12th, 1881, by which said Will, Testator bequeathed various pecuniary legacies to the various legatees named in said Will, but made no disposition of the Real Estate of which he was seized, and possessed, all of which will, appear by a certified copy of said Will, here with exhibited, marked Exhibit No. 2.

Your Complainants further charge that the said Daniel Straffer having by his last Will made no disposition of the Real Estate of which he died seized and possessed as to it, died intestate, and that the said lands, descended to his heirs at law, as tenants in common.

That the said Daniel Straffer having died without leaving a widow, and childless, left the following brothers, and sisters, and children of deceased sisters his heirs at Law as follows.
