I, Daniel Strafer of Frederick County, State of Maryland, being in  
perfect health of body and mind, sound disposing memory and understanding  
the certainty and the uncertainty of the time thereof, and being desirous to settle my  
worldly affairs and thereby be the better prepared to leave this world when it shall please  
God to call me hence, do therefore make and publish this my last Will and testa-  
ment in manner and form following, that is to say, First and principally I commit  
my soul into the hands of Almighty God and my body to the earth to be decently  
buried at the discretion of my Executor hereinafter named and after debts and funeral  
charges are paid, I devise and bequeath as follows—

Item 2d. - I give devise and bequeath unto my wife's niece Mary C. Menden  
the sum of Two hundred Dollars.

Item 3d. - I give devise and bequeath unto Lydia C. Menden the sum of One  
Hundred & Twenty-five dollars

Item 4th. - I give devise and bequeath unto John Hardy the sum of Fifty five dollars.

Item 5th - I give devise and bequeath unto Edwin S. Wacker the sum of Twenty-  
five Dollars

Item 6th - I give devise and bequeath unto Lucina B. A. Wacker, (Daughter of  
Joshua Wacker) the sum of Twenty-five Dollars.

Item 7th - I give devise and bequeath unto Ann M. Wacker (Wife of Joshua Wacker) the sum  
of One hundred Dollars

Item 8th - I give devise and bequeath unto Sarah Lyons the sum of Twenty-five Dollars

Item 9th - I give devise and bequeath unto the Company of the Dist. Olivet Cemetery (of  
Frederick City Maryland) fifty Dollars the interest of the same to be applied to the keeping of  
my half of Lot in the above named cemetery in order

And lastly I do hereby constitute and appoint my friend Dennis Remsburg to be my sole  
Executor of this my last Will and testament revoking all former wills by me heretofore made ratify-  
ing and confirming this and none other to be my last Will and Testimony And allowing and grant-  
ing unto him as compensation for his services in settling up my Estate, the sum of Five per cent Com-  
mission.

In testimony whereof I hereto set my hand & seal, on this 12th of May, Eighteen hundred and  
eighty one, signed sealed published, and declared by the above named Daniel Strafer, as  
for his last Will and testament in our presence, who at his request, in his presence of each other hereunto
