This Deed made this sixteenth day of December in the year Eighteen hundred and seventy two by us Jared Hanks and Charlotte Hanks his wife, Witnesseth that in consideration of the sum of seven hundred and sixty three dollars with the said Jared Hanks and Charlotte Hanks his wife do grant unto Reuben G Stevens the following piece or parcel of land, Beginning for the first part at the North corner of Joseph Patners Lot and running 1st North Eighty two degrees West fifty five perches to a Stone 2^d South one and a half degrees West forty and a half perches 3^d South Eighty two and a half degrees East twenty eight perches 4th South one and a half degrees West ten and a half perches, 5th South Seventy seven degrees East twenty eight perches 6th North fifteen degrees East forty three perches 7th North Eighty two degrees West thirteen and a half perches then with a straight line to the beginning, Containing seventeen acres and twenty eight square perches, more or less.
