In the name of God, Amen, I, Absalom Cline of Frederick County in the State of Maryland (and now in Howard County) do make and declare this to be my last will and testament that is to say, after my just debts and burial charges are paid, I give and devise as follows to wit, I give, devise & bequeath to my Cousin Rachel R. Albaugh wife of Jasper Albaugh and to my sister, Sarah E. Dorsey, wife of Nimrod B. Dorsey, all my property, real personal and mixed, of every sort kind and description wherever situated that I now have or may hereafter have any right to or interest in; to them, the said Rachel R. Albaugh and Sarah E. Dorsey for their respective & separate use and benefit, apart from the control of their respective husbands, and to their respective heirs and assigns forever. And I hereby appoint the said Jasper Albaugh Executor of this my last will and testament, hereby revoking and annulling all former will made by me, satisfying and confirming this and none other, to be my last will and testament. In testimony whereof, I hereunto set my hand and seal this 30th day of June, 1880.
