At the Execution of the annexed Commission issued out of the Circuit Court for Frederick County sitting as a Court of Equity and directed to Clayton O'Keedy and William Wilson Commissioners therein named and being also the Standing Commissioners of said Court, duly appointed qualified and sworn and empowering them or either of them to examine evidences in a Cause depending in said Court between Samuel Glisson Complainant and Jasper Albaugh, Rachael R. Albaugh, William Warner, Nimrod B. Dorsey and others defendants. I, Clayton O'Keedy one of the Commissioners named in said Commission, having met at my office in Frederick City, Maryland on the first day of June A.D. 1883, pursuant to previous notice thereof given and in the absence of William Wilson Commissioner did there and there proceed to take the following testimony, to wit:

The Complainant filed with the Commissioner as evidence Exhibits Nos. 1. 2. 3. 4. 5. 6. 7 and 8 and Exhibits Nos. 3. 4. and 5 Original which are herewith returned by said Commissioner William W. Warner a witness of lawful age (one of the defendants) being duly sworn and examined to Interrogatories filed with the Commissioner by the Complainant and herewith returned deposes and says to the 1st interrogatory

1st Ans.

To the 2nd Inter

2nd Ans. I know the parties to this suit and have known them for some years.

To the 3rd Inter

3rd Ans. I knew the said Absalom Eline, He is dead. He died April 1. 1883 at his residence in Frederick County.

To the 4th Inter

4th Ans. He died testate.

To the 5th Inter

5th Ans. He died unmarried and had never been married

To the 6th Inter

6th Ans. I knew them. Rachael R. Albaugh is the wife of Jasper Albaugh. Sarah E. Dorsey is dead; she died in Howard County Maryland sometime last year (1882)

To the 7th Inter

7th Ans. Sarah E. Dorsey left a husband now surviving her. His name is Nimrod B. Dorsey he lives in Howard County Maryland; he is an adult but his exact age I do not know. She also left some children whose names and ages I do not remember, who reside in Howard County also.

To the 8th Inter

8th Ans. Absalom Eline died seized and possessed of an interest in about 53 $\frac{3}{4}$ acres of land situated in Frederick County, Maryland, which he bought of me, (William Warner) Attorney for the heirs of George Eline deceased. He had no deed for it. The said land lies on the West bank of the Linganore Creek and extends on the West to the road leading from Maplesville, North to the Liberty road. It adjoins the lands of William Baker and Andrew Alexander on the North; Nimrod B. Dorsey on the East; Adam Garber on the South and E. C. Buckley on the West. It is worth about \$1500. Absalom Eline still owes one-third of the Original purchase money amounting to \$390⁰⁰. which is not payable till the death of his mother Mrs Sarah Eline; but interest on the same is to be paid to her annually during her lifetime
