1st Int.

Do you know the parties to this suit; if yea, how long have you known them?

1st Ans. I know them, The most of them I have known from boyhood.

2nd Int.

Did you know Daniel P Duvall, late of Frederick County, and is he living or dead? If dead, when and where did he die and did he die testate or intestate?

2nd Ans. I knew Daniel P Duvall late of Frederick County. He is dead. He died in Frederick City on January 24, 1882. and he died intestate.

3rd Int.

Did said Daniel P Duvall die seized and possessed of any real estate? If so, describe the same, state where the same is located and give its quantity and value?

3rd Ans. He died seized and possessed of real estate consisting of a farm in New Market District, Frederick County, containing about 124 acres and worth about \$50⁰⁰ per acre.

4th Int.

Look at Exhibits 1, 2 & 3 and state whether the land described in Exhibit No 1 is that of which said Daniel P Duvall died seized and possessed, excepting that described in Exhibits Nos 1 & 2?

4th Ans. I look at the exhibits now shown me. Exhibit No 1. does describe the land of which said Daniel P Duvall died seized and possessed except about fifteen (15) acres sold off during his lifetime.

5th Int.

Did said Daniel P Duvall die married or unmarried and did he leave any children or parents surviving him and if not, state who was his heirs at law; Give the names of all his brothers and sisters living at the time of his death, their ages and places of residence, and the names of their husbands and wives, if married, and in case said Daniel P Duvall had any brother or sister who died before he died leaving children, then give the names, ages and places of residences of such nephews and nieces. Give the names of all of the heirs at law of said Daniel P Duvall and their relationship to him.

5th Ans. He died unmarried and left no parents or children surviving him. He left brothers and sisters surviving him as follows viz:

(1) A sister, Mary R Duvall, aged about 67 years who is unmarried and who lives in Frederick City, Maryland.

(2) A sister, Elizabeth A Bank, a widow, aged about 64 years of age who lives in Frederick County Maryland.

(3) Ellen J Dertzbaugh, a sister, who is a widow aged about 58 years and who lives in Frederick County.

(4) A brother of James Duvall married to Mary O Duvall both of whom are adults and residents of Frederick County.

(5) & (6). Two brothers John W Duvall and Benjamin F Duvall both of whom died intestate in Frederick County, in the month of May A.D. 1882. John W Duvall left no widow. Benjamin F Duvall left a widow Sidney Jane Duvall aged about 48 years. I know that both of these brothers left children, but the names and ages of their children I do not know.
