This Deed, made this twentieth day of March, in the year of our Lord, One thousand Eight hundred and Seventy five by Dr. T. E. R. Miller and Margt. E. Miller his wife of Frederick County State of Maryland, Witnesses, that in consideration of the sum of six thousand Dollars current money, in hand paid the said T. E. R. Miller and Margt. E. Miller his wife doth give unto Ann R. Still of Frederick County in the State aforesaid the following Tract or Tracts of land called "Bulley View" Beginning for the part hereby intended to be conveyed at the end of Sixty two perches on the fifteenth line of the whole tract and running with said line several South fifty two degrees East One hundred and twenty perches, thence North fifty five degrees East forty eight perches, thence North thirty degrees West one hundred and twenty three perches this line being up the Turnpike thence by a straight line to the beginning containing fifty eight acres of land more or less, being part of the same tract or tracts which was conveyed to the said Dr. T. E. R. Miller and wife by deed dated March 11th 1870 and recorded in Liber to Me. No 5 folio 50 &c. one of the Land Records of Frederick County as by reference thereto will more fully appear.
