Your Orators complaining Says:

1. That a certain Gideon Slifer late of Frederick County deceased, was in his life time seized and possessed of a small tract of land containing about one acre of land improved by a one and a half story log dwelling bying and being in Middlestown District in Frederick County Maryland which was conveyed by Daniel Swemmer and wife to the said Gideon Slifer by deed dated, April 19th 1853. as will fully appear by a certified copy of said deed herewith filed and marked Exhibit No 1. which is prayed to taken as part of this Bill as fully as if herein at large set forth.
2. That the said Gideon Slifer departed this life in Frederick County aforesaid intestate in or about the year A.D. 1879 being seized and possessed of the land aforesaid and that he left no widow surviving him.
3. That the said Gideon Slifer left as his only heirs at law and who are yet surviving him the following children and grand children viz:—
 - (1) Morris L. Haupt married to Mary Jane Haupt.
 - (2) Lauretia F. Morgan married to Andrew J. Morgan; all of whom are adults and residents of Frederick County Maryland and
 - (3) Mary J. Gantz married to Louis E. Gantz
 - (4) Cordelia C. Haupt
 - (5) Joshua C. Haupt all of whom are adults and residents of the State of Illinois and
 - (6) Charles S. Haupt and
 - (7) Lean R. Haupt both of whom are infants under the age of twenty one years and residents of Frederick County, Maryland.
4. That the aforesaid real estate descended upon and vested in the above named heirs at law of said Gideon Slifer as tenants in common at his death.
