That all of said parties reside in Frederick County Maryland excepting Ezra Green and his wife who reside in the State of Indiana, that all are adults excepting the said Francis F Green

These Complainants further represent and charge that the said real estate of which the said Francis Green died, seized and possessed and described in Exhibit No 1. vested in and rests in as tenants in common the said Washington Green, Elias Green, Jacob Green Christian Green Ezra Green, Caroline Holmes and Francis F Green and that as such they are seized of the same.

These Complainants further charge that said real estate is not susceptible of division among said parties without great loss and damage and that it would be to the interest of all of said parties and especially the infant Francis F Green to have the same sold under the direction and decree of this Honorable Court and the proceeds of said sale divided among those entitled to the same.

To the end that the said Elias Green and Sarah Green his wife Jacob Green, Christian Green and Susan Green his wife, Ezra Green and Green his wife whose Christian name is unknown to these Complainants, Horatio Holmes and Caroline Holmes his wife, and Francis F Green may answer the matters and things alleged in this Bill of Complaints and that a decree may be passed by this Honorable Court directing said real estate to be sold and the proceeds thereof to be distributed among the above named parties as heirs of the said Francis Green May it please your Honors to issue a subpoena directed to the said Elias Green and Sarah Green his wife, Jacob Green, Christian Green and Susan Green his wife, Horatio Holmes and Caroline Holmes his wife and Francis F Green of Frederick County Maryland commanding them and each of them to be and appear in this Honorable Court on some day to be therein named to answer the premises and abide by and perform such decree as may be passed therein. And may it please your Honors to further order an order of publication to issue notifying the said nonresidents Ezra Green and Green his wife whose Christian name is unknown to these Complainants of the object and substance of this bill of Complaint and to be and appear on this Honorable Court on some certain day to be therein named to answer the premises and abide by and perform such decree as may be passed therein. This Indenture made this twenty ninth day of January Eighteen hundred and thirty three between Albert Ritchie and Catharina L Ritchie his wife and Mary Ott heirs at law and representatives of Thomas Beatty late of Frederick County in the State of Maryland (deceased) of the one part and Francis Green of the County and State afo of the other part, Witnesseth that they the said Albert Ritchie & Catharina L his wife and Mary Ott for and in consideration of the sum of seventy two dollars current money to them in hand paid by the said Exhibit No 1. Francis Green before the sealing and delivery of these presents the receipt whereof they the said Albert Ritchie & Catharina L Ritchie his wife and Mary Ott doth hereby acknowledge hath granted bargained sold aliened enfeoffed and confirmed and by these presents do grant bargain sell alien enfeoff and confirm unto the said Francis Green his heirs and
