Order of Publication

The object of this suit is to procure a decree for the sale of the real estate situated in Frederick County Maryland, of which Francis Green died, seized and possessed and for the distribution of the proceeds of said sale among his heirs at law and those entitled thereto according to their just proportions

The Bill states that sometime in the year Eighteen hundred and seventy three a certain Francis Green of Frederick County, Maryland departed this life testate seized and possessed of valuable real estate situate lying and being in Frederick County Maryland, containing thirty six acres of land more or less all which will appear by reference to Exhibits filed with said Bill as a part thereof

The Bill further represents and charges that by his last will and testament duly executed according to law and a certified copy of which as filed in the office of the Register of Wills of Frederick County, is filed as an Exhibit to said Bill the said Francis Green devised said real estate to his wife Barbara Green for and during her natural life and after her death the fee to his grand child Caroline Holmes
