1. For a writ of Subpoena directed to the said Mary A Gaver widow; Otto S Gaver, Charles B Gaver, and Joseph W Gaver Executors of the last will &c of Joseph Gaver; George W Gaver and Susan Gaver his wife; Otto S Gaver and Kate Gaver his wife; Charles B Gaver Joseph W Gaver and Margaret C Schaeffer all of Frederick County; and James H Michael and Jane R Michael his wife and Albert T Fiery and Melinda C Fiery his wife of Washington County Maryland Commanding them and each of them to be and appear in this Court on some Certain day to be named therein and to answer the premises and to abide by and perform such order or decree as may be passed herein

2 And for an order of publication against the said Jeremiah R Gaver a nonresident of the State of Maryland and resident of the territory of Montana giving him notice of the object and subject of this Bill and warning him to appear in this Court in person or by solicitor on some day certain to be therein named to show cause, if any he has why a decree should not be passed as prayed

At the request of Joseph Gaver the following deed was recorded January 31st 1862.

This Deed made this 31st day of January in the year Eighteen hundred and sixty two by Daniel Main of Frederick County in the State of Maryland Witnesseth that in Consideration of Seven thousand four hundred and eighty five dollars the said Daniel Main doth grant unto Joseph Gaver of Frederick County and State of Maryland all that parcel or tract of land and ground situated in Frederick County being part of a tract of land called "The year of Plenty" which is described as follows: Beginning for the same at the beginning of the whole tract and running South 45° East 2¹/₂ ps to a Stone North 77° East 47 ps to a Stone a corner of the 2¹/₂ acre lot conveyed to Moses H Strider, then with the 3rd & 4th lines of said lot, reversely North 78° East 16 ps, South 52¹/₂° East 22 ps to near a large stone in the public road leading to Myersville then with said road two courses and distances viz: North 63° East 9¹/₂ to a Stone, North 86° East 11¹/₂ ps to a corner of Enoch Paffenbergers lot, then with it three courses and distances viz: North 14° West 11¹/₂ ps North 78° East 28 ps South 21° East 17 ps to said public road then with it two courses and distances viz: North 89° East 6¹/₂ ps to a Stone South 50° East 9¹/₂ ps to the beginning of the 13¹/₄ acre lot conveyed to John Smith then with it reversely N 43° East 57¹/₂ ps to intersect the 14th line of a tract of land called "Metzger's Home" at the end of 42 perches thence with said 14th line of Metzger's Home North 57¹/₂ West 24¹/₂ perches to a Stone standing at the end of said line then with the one quarter acre lot conveyed by said Daniel Main and Joseph Gaver wife to William Metzger three courses and distances viz: North 57¹/₂ West 1¹/₂ ps to a Stone North 12° West 40 ps to a flint Stone North 20° East 1¹/₂ ps to the beginning of the 16th line of said Metzger's Home then with said 16th line North 34° East 16 ps to the old Hagerstown Road then with said road one course North 55° East 1 ps to Cyrus Postgates part of the year of Plenty then with it two courses and distances viz: South 34° West 16 ps South 11° West 7¹/₂ ps North 68° West 27 ps, South 79° West 19 ps North 27° West 24 ps South 70° West 20 ps, North 42¹/₂ West 27 ps, South 38° West 58 ps South 55° West 16 ps North
