Interrogatories to be propounded to witnesses to be produced and sworn on the part of the Plaintiff:

Interrogatories

- Are you or not acquainted with the parties to this suit or any of them? If you know how long have you known them?
- Were you or not acquainted with Joseph Gaver late of Frederick County? If you is he dead or alive? If dead when and where did he die and did he die testate or intestate?
- Look at paper now shown you, marked Exhibit No 7, and state whether or not the same is a true copy of the last will and testament of the said Joseph Gaver deceased and state who are the Executors therein named and whether letters testamentary have been granted to any one on the same?
- Did the said Joseph Gaver dec leave a widow surviving him? If you give her name, age and state whether or not she is still living and if so where?
- State whether or not the said Mary A Gaver has renounced the terms and provisions of said will? Look at paper marked Exhibit No 7 1/2 and say whether or not the same is a copy of said renunciation? and also whether any one is empowered under said will to sell said the real estate mentioned in these proceedings since her renunciation?
- Has or was not the said Joseph Gaver dec seized and possessed of any real estate situated in the State of Maryland at the time of his death? If you describe it and tell where it is situated? Look at paper marked Exhibits Nos 1, 2, 3, 4, 5 and 6 now shown you and tell whether said Exhibits correctly describe the said real estate and give its value?
- Did or did not the said Joseph Gaver dec leave any children surviving him? If you, give their names, ages and residence and if any are married, state the same facts of their husbands and wives as the case may be? State also whether or not the said named children or any of them are the same or different persons from those named as legatees and devisees in the will of the said Joseph Gaver deceased?
