

No 5222. Equity.

1st. This respondent for answer admits that John Derr, Senior did, seized and possessed of a large estate real and personal, that he left a last Will and testament, dated December 14th. A.D. 1829 that the said Real estate is fully described in said Will and is situated in Frederick County and State of Maryland, as is set forth in said Bill.

2. This respondent admits that the said John Derr, Sr. died without having altered or changed said Will.

6. This respondent admits that upon the death of the said Catherine Reese, said farm descended to the descendants of said John Derr, Sr. except his said son John.

This respondent further answering admits that the said Elizabeth Getzendanner, daughter of the said John Derr, Sr. daughter this life some time ago leaving the following children and descendants of deceased children, namely, a daughter Mary Bechtel married to John Bechtel, a daughter Catherine Lighter who was married to Henry Lighter, now deceased, a son Thomas E. Getzendanner who is married whose wife's name is -

Charlotte Getzendanner the widow of a deceased son John D. Getzendanner, John W. Getzendanner (whose wife's name is Melinda Getzendanner) a son of John D. Getzendanner, deceased, Annie E. Getzendanner the widow of Samuel P. Getzendanner, now deceased, who was a son of said John D. Getzendanner, deceased, and Edith Regina Getzendanner and Catherine Elizabeth Getzendanner infants children of Samuel P. Getzendanner, deceased, Ann Getzendanner widow of Jacob Getzendanner, now deceased, who was a son of said Elizabeth Getzendanner, Virginia Chenderffer (whose husband is named Frederick H. Chenderffer, a daughter of said Jacob Getzendanner, deceased, Elizabeth Getzendanner, a daughter a daughter of said Jacob Getzendanner, deceased, and the following children of Ann Rebecca Hughes, a deceased daughter of said Elizabeth Getzendanner, deceased, namely, William S.
