Getzendanner now deceased, who was a son of said John D. Getzendanner deceased, and Edith Regina Getzendanner and Catherine Elizabeth Getzendanner infant children of said Samuel P. Getzendanner deceased, Ann Getzendanner widow of Jacob Getzendanner now deceased who was a son of said Elizabeth Getzendanner, Virginia Oberdeffer (whose husband's name is Frederick M. Oberdeffer) a daughter of Jacob Getzendanner deceased and Elizabeth Getzendanner a daughter of said Jacob Getzendanner deceased, and the following children of Ann Rebecca Hughes, a deceased daughter of said Elizabeth Getzendanner, deceased, namely William S.
