This Deed, made this sixth day of July, in the year eighteen hundred and sixty by John Loats of Frederick County State of Maryland, Witnesseth that John Loats appointed by the Honorable Madison Nelson Circuit Judge of the Third Judicial Circuit of the State of Maryland in pursuance of an order of said Judge in said application Number 4384. Insolencies, did on the fifteenth day of March Eighteen hundred and sixty sell unto Catharine Derr wife of said Daniel Derr the real estate hereinafter described, and for the sum of Two thousand seven hundred and forty five dollars which sum of money has been paid, Now this deed witnesseth that John Loats Trustee of Daniel Derr in consideration of the above recited premises have granted, bargained, and sold to the said Catharine Derr all that lot or piece of ground situate in Frederick Town heretofore conveyed by George Kissinger to Daniel Derr by deed recorded in Liber C. S. No. 10. folios 221, 222, & 223, one of the Land Records of Frederick County, also all that lot or parcel of ground situate in Frederick Town heretofore conveyed by Widow Bantz and wife to said Daniel Derr by deed recorded in Liber C. S. No. 21. folios 216 & c. one of the Land Records of Frederick County; Also all that lot or piece of ground situate in Frederick Town heretofore conveyed by George St. Dunbaugh and wife to said Daniel Derr by deed recorded in Liber C.
