This Deed made the Ninth day of October in the Year Eighteen hundred and Fifty-Eight by Charles F. Wantz and Amanda his wife, Francis Hamburg and Sarah Ann his wife of Frederick County in the State of Maryland and Schirer and Elizabeth his wife of Adams County in the State of Pennsylvania. Witnesseth that in consideration of Four hundred and fifty Dollars the said Charles Wantz & Amanda his wife, Francis Hamburg and Sarah Ann his wife & Isaac Schirer and Elizabeth his wife doth grant unto Lydia Teaser of Frederick County in the State of Maryland all their right, title, interest and Estate whatsoever of, in and to those undivided tracts or parts of tracts of Land lying & being in Frederick County aforesaid, and joining lands of Daniel Little, John J. Deely, Barney Koontz and others which Jacob Teaser late of Frederick County, died seized, containing about One hundred & thirty-three acres of Land -
