The Bill of Complaint of Adam Wesley Palmer, and Rebecca
Palmer, his wife of Frederick County, Maryland humbly complaining sheweth,
1st That in the month of February in the year eighteen, and eighty four
a certain Daniel Palmer of Frederick County, Maryland departed
this life intestate seized, and possessed of certain Real Estate or Tracts
of Land lying and being in the County aforesaid, the first part being

Gaver, respectively by Deeds, certified copies of which, as they are recorded

as Recorded among the Land Records of Frederick County is
herewith filed, as Exhibit No. 5 to this Bill of Complaint, less the
Tracts of Land conveyed by the said Daniel Palmer and wife
to Adam Wesley Palmer and Rebecca, his wife, Peter Groffmehl,
Mary Ann Altaville, and Lawson King by Deed, certified copies
