This Deed made this 27th day of February in the year 1873 by Christian Harshman & Mary Harshman his wife, Witnesseth that in consideration of the sum of One Hundred Dollars the said Christian Harshman and Mary Harshman do grant unto Pointon Stottlemeyer, all the following described Real Estate and being part of a tract of land called "Seven Fold" situated in Catholic District Frederick County, Maryland, Beginning for the same at the end of the 9th. line of a tract of land sold by Christian Harshman & wife to Ephraim Gilbert, and running thence North 28 perches to a stone planted South 55° East 39.36 perches to a stone 7° East 26.60 perches to the South side of a large Rock, thence North 88° West 40.76 perches to the place of beginning containing 6 3/4 Acres more or less. Beginning for a second parcel at the end of 14 Perches on the 5th line of the above said purchase by E Gilbert of C. Harshman and running thence South 6° East 25.40 perches to a Sassafras Tree North 68° West 6.40 perches to a corner North 4° West 25 perches to a Point in a public road South 71° East 6.44 perches to the place of Beginning containing 3 rods & 28 square perches more or less. The said C Harshman & Wife, Excepts a road through the 2nd Parcel to Jacob Harshmans fields so long as he the said J. Harshman keeps said fields.
