To the 1st Interrogatory - 1st Ans. My name is Frederick Kohlhafe, my age 42 years and I reside in Frederick County, Maryland.

To the 2^d Inter 2^d Ans. I know all the parties and have known them for some years. I am one of them myself.

To the 3^d Inter 3^d Ans. I knew Jane Kohlhafe in her lifetime; she is dead, she died on November 4th, 1885, in Frederick County, Md. and died intestate.

To the 4th Inter 4th Ans. She did die seized and possessed of real estate situated in Frederick County; consisting of about 88 acres of land, or a little over. I look at Exhibit No 1. now shown me, and that describes the land of which she died seized and possessed, less the land described in Exhibit No 2 filed in the case.
