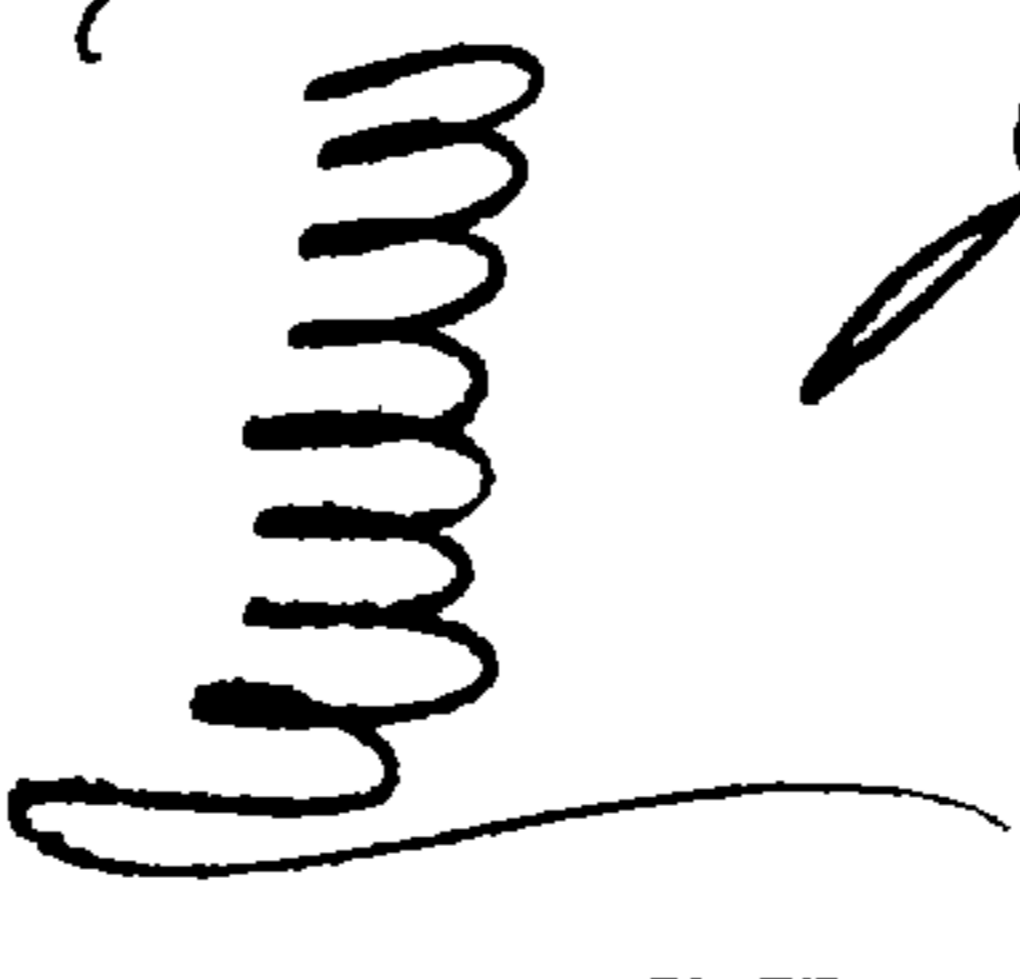
At the Request of Henry Pampel & John G. Rodock the following deed was Recorded February 17th 1858.

Rodock, of the said County & State of the other part, Witnesseth, that for & in consideration of the sum of Six Hundred Dollars current money by the said Henry Pampel & John G. Rodock to the said John Walter in hand paid, at & before the sealing & delivery of these presents, the receipt whereof is hereby acknowledged, the said John Walter hath bargained & sold, aliened & enfeoffed & by these presents doth give, grant, bargain & sell, alien & enfeoff, release, convey & confirm unto the said Henry Pampel & John G. Rodock their heirs & assigns, as Tenants in Common, all the right, title, interest & Estate, both at law & in Equity, of him the said John Walter of, in & to all that real Estate & premises heretofore conveyed to Henry Pampel, John G. Rodock & John Walter by Joshua Dill & wife by deed, dated the sixteenth of June Eighteen Hundred & forty nine & recorded in Liber N.B.P. No. 10. folios 258 & 259, One of the Land Records of Frederick County And the said John Walter doth also by these presents bargain & sell, assign, transfer & set over to the said Henry Pampel & John G. Rodock, all the share, right, title & interest of him the said John Walter, of, in & to the whole stock in trade, Tools, Machines, Books of Account & out-standing Debts, heretofore belonging to the firm of Pampel, Walter & Rodock, & every part & parcel thereof, to have and to hold the said Real Estate, with the appurtenances thereunto belonging to the said Henry Pampel & John G. Rodock, their heirs & assigns forever. And to have to hold said personal Estate, accounts & out-standing debts to the said Henry Pampel & John G. Rodock, their Executors, Administrators & assigns forever -
