


Wächter, in Equal shares, share and share alike, and the remaining one share to my grandson Luther H. M. Wächter son of my deceased son Jacob H. Wächter and upon the further trust, that the said Trustees or the survivors of them collect the rents and profits of said Home Farm, so long as the said Philip Wächter lives and pay the same less Expenses and commissions over to him the said Philip Wächter during his natural life for his benefit comfort and support and upon the death of him the said Philip Wächter to sell said Home Farm at either public or private sale, on such notice, at such place and on such terms as the said Trustees or the survivors of them may deem best, and to apply the proceeds of sale of said Home Farm to the payment in the first place of the costs and Expenses attending such sale, including and Chancery Commission and reasonable Counsel fees for preparing Report of sale and ratification thereof, then to pay Susannah Wächter the wife of said Philip Wächter if she survives him the said Philip Wächter the sum of fifteen hundred dollars that being the amount she received from her father's estate and paid to him the said Philip Wächter and then to divide the remainder of the proceeds of sale of said Home Farm into twelve Equal shares and to pay one share thereof to said Susannah Wächter, one share to Lewis F.
