The Petitioner of Complaint of Barbara A.

Pirily of Frederick County, Maryland, respectfully represents unto your Honors,
 1st. That she resides in Frederick County Maryland and is the surviving
 widow of Samuel Pirily, who departed this life, in the year Eighteen
 Hundred and seventy seven, in Frederick County, Maryland,
 leaving a last will and testament, duly executed according to law,
 a certified copy of which, will as probated and recorded in the
 Office of the Register of Wills of Frederick County, is filed herewith
 as Exhibit No. 1, to this Bill, which Exhibit together with such other
 Exhibits as the Plaintiff may file herewith, she prays may be taken and
 considered as a part hereof.

2^d. That at the time of his death, the said Samuel Pirily in connection
 with other real estate, was seized and possessed of a certain lot or
 parcel of land containing four acres of land and improved with a dwelling
 house and other buildings situated at Ladsburg in Frederick County,
 Maryland, which by said last will and testament he devised and
 gave to the Plaintiff for and during the term of her natural life,
 with the additional proviso "Except if the said Barbara A. Pirily
 should marry, then the said house and lot, is to be sold and the
 money equally divided between my lawful heirs then living" all of
 which will fully appear by reference to Exhibit No. 1, to this Bill.

3^d. That the said Barbara A. Pirily has not married and has no
 intention of doing so.

4^d. That on the death of the said Barbara A. Pirily said house
 and four acres of land, will vest in Samuel M. Pirily, Lily J.
 Pirily now Lily J. Dudders, Elizabeth Pirily now Elizabeth Hoons
 Mary K. Pirily and Morris A. Pirily each having an equal interest
 therein, all of whom reside in Frederick County, Maryland, with
 the exception of Elizabeth Hoons, who with her husband Robert L.
 Hoons lives in Carroll County, Maryland and Lily J. Dudders,
 who with her husband William S. Dudders resides in the State of
 Pennsylvania, and are non residents of the State of Maryland; that
 all of said parties are over twenty one years of age, excepting Morris
 A. Pirily, who is an infant.

5^d. The Plaintiff further represents and charges that she is growing
 older in life being now 58 years old, that said house is a large
 building and requires considerable attention and money to keep it
 and the other buildings on said land in proper repair and condition;
