At the request of Thomas Hyde the following Deed { Stamp } was recorded June 20<sup>th</sup> 1868.

This Deed made this thirtieth day of January in the year Eighteen hundred and Fifty Eight by Thomas W. Harn of Frederick County, and State of Maryland.

Witnesseth, that in consideration of the sum of thirty Dollars the said Thomas W. Harn doth grant unto Thomas Hyde of said County & State, all of the following described parcel of land being part of a tract of Land called "The Resurvey on Point Look Out" situate lying and being in Frederick County, Maryland it being part of Two thousand acres of land laid off for Mary Sturman (late living) Beginning for the same at the end of the 29<sup>th</sup> line of said Resurvey and running with said line reversed, & bounding thereon allowing 1<sup>3</sup>/<sub>4</sub> for variation North 49<sup>1</sup>/<sub>4</sub> west 40 poles thence by lines of division South 30 west 26 poles South 63<sup>3</sup>/<sub>4</sub> East 51 poles North 19 East 19 poles to the end of 8<sup>7</sup>/<sub>8</sub> poles on the 30<sup>th</sup> line of aforesaid Resurvey and with said line reversed allowing as before North 86<sup>3</sup>/<sub>4</sub> West 8<sup>7</sup>/<sub>8</sub> poles to the first place of beginning containing six & a quarter acres and thirty square poles of land more or less in fee simple.
