This Deed made this 30th Day of December Eighteen hundred and Eighty two
by Thomas W. Ham of Frederick County State of Maryland, with intent that in Consideration
of the sum of forty two dollars, the said Thomas W. Ham doth grant unto Edward
D. Mairiel of said County and State, the following described parcel of Land situate
lying and being in Frederick County State of Maryland and being a part
of that parcel of Land conveyed to said Thomas W. Ham by Deed from
John Day and wife dated December 26th 1851 Beginning at a stone at
the end of 63¹/₂ perches on the 7th line reversed of said Deed thence with
the 2nd line of the deed from said Thomas W. Ham to Edward D.
Mairiel dated May 22nd 1849 North 30¹/₄ East 18 perches then by line of
division North 1¹/₂ West 16³/₄ perches to a stone 30¹/₂ West 22 perches to intersect
the aforesaid 7th line thence with it reversed South 5¹/₂ East 16 perches to
the Beginning Containing 2 acres and 139 perch of Land in fee simple
