Testimony.

In pursuance of the annexed order of the Court and notes given by the Solicitor to me, for the plaintiffs in the above entitled cause, I Clayton O. Keady, one of the regular Examiners of said Court, duly appointed, qualified and sworn having assigned the 17th day of January A.D. 1879 at the office of J. M. Bissell, Esq. in Frederick City as the time and place for taking the testimony in this cause and having given due notice thereof to the parties concerned and at the appointed time and place proceeded to take the following testimony to-wit:

The Plaintiffs filed with the Examiner as evidence, Exhibits "A", "B", "C" & "D" which are herewith returned by the said Examiner. Oliver B. Palmer (one of the Plaintiffs) a witness of lawful age produced on the part of the Plaintiffs being duly sworn and examined on oath deposes and says:-

My name is Oliver B. Palmer, my age 25 years, I reside near Ellerton in Frederick County, Maryland, I know all the parties to the suit, James O. Palmer, late of Frederick County, the decedent, mentioned in these proceedings, was my father, He died many years ago and was at the time of his death seized and possessed of the real estate mentioned in this cause, consisting of a little over six acres of land situated in Ellerton in Frederick County, Md, and which is worth about \$300. I look at Exhibit "A", "B", "C" and "D", now shown me and they correctly describe the Real Estate.

My said father left a widow, Caroline Palmer, who died in the year 1895, and the following ten children his heirs at law, viz:

1. Oliver B. Palmer, whose wife's name is Minnie M. Palmer, both of whom are adults living in Frederick in Frederick County,
2. Lewis F. Palmer who is married to Susan Palmer, his wife, both adults residing in the State of Ohio,
- 3rd. Daniel W. Palmer whose wife's name is Mary (called in the Record Sarah) both of whom are adults living in Montgomery Ohio,
- 4th Sarah H. Palmer whose wife's name is Catherine both of whom are adults living in Montgomery County Ohio,
- 5th A daughter Sarah who is intermarried with David E. Matter both of whom are adults and residing in Frederick County, Md.
- 6th A daughter Elizabeth who is intermarried with Clayton A. Fox both of whom are adults living in Frederick County, Md.
7. James H. Palmer whose wife's name is Laura both adults living in Frederick County, Md.
8. Charles U. Palmer whose wife's name is Mary both are adults living in Frederick County,
9. A daughter Katie who is married to Frank Cooper both adults living in Frederick County Md.
- 10 A daughter Susan who married Clayton A. Fox and who died since my father's death leaving three children viz: Estie Fox Anna Fox and Cora Fox all of whom are under twenty one year of age and reside with their father Clayton A. Fox in said County,
