Pempel, one of the regular examiners of your Honorable Court, then proceeded to take and do take the following depositions at my office in Frederick City, Frederick County, Maryland, at the hour of 10 o'clock A. M.

James M. Kerrigan a witness of lawful age, produced on the part of the plaintiffs, being sworn and examined, deposes and says as follows:-

1st Int. State your name, age, and residence?  
Ans. James M. Kerrigan, age 44 years, resides in Emmitsburg, Frederick County, Md.

2nd Int. Do you know the parties to this suit?  
Ans. I do.

3rd Int. Did you know Edward J. Lefevre in his life time, if yes, is he dead or living, and if he is dead, did he die intestate or testate?  
Ans. I did, he is dead, he died intestate about April 11th 1877.

4th Int. Was he seized and possessed of any real estate at the time of his death?  
Ans. Yes. The Real Estate described in "Exhibit B. in this case, "Exhibit B" filed.

5th Int. Did he leave any personal property?  
Ans. No Sir

6th Int. Was the said Edward J. Lefevre indebted to you at the time of his death?  
Ans. He was; in the account set out in "Exhibit A." herewith filed, "Exhibit A" filed.

7th Int. What is the said real estate worth?  
Ans. About \$1000.

8th Int. Did he leave any heirs at law; if so, give their names, ages, residences, and if married or single?  
Ans. He did as follows.-

Jacob A. Lefevre, an adult over 21 years of age and Catherine Lefevre his wife an adult both reside in Baltimore City, Md.

The children of Susan Klive, a deceased aunt of Edward J. Lefevre, namely Francis Klive and his wife, Mrs. Francis Klive both adults, residing in the State of Ohio, and non-resident of the State of Maryland, Edward Klive and Mrs. Edward Klive both adults residing in the State of Kentucky and non-residents of the State of Maryland, Henry Klive an adult over the age 21 years and last heard from in the State of Ohio, and has not been heard from for over 7 years,

Henry Withrow a son of Mrs. Withrow a deceased aunt of the said Edward J. Lefevre an adult over 21 years of age and when last heard of resided in the State of West Virginia and a non-resident
