may come in and contribute to the expenses of these proceedings against Charles N. Hauer
and Clara E. Hauer his wife, Margaret H. Stouch & Roy M. H. Stouch her husband Britton
H. Hauer and Susan Hauer his wife, George W. Hauer & Belle Hauer his wife, J.
Harry Hauer, W. D. Jenks Hauer, Jessie May Hauer, Mamie L. Hauer and Annie Kate
Hauer, all defendants in your Honorable Court exhibited, respectfully shews,
1st That the plaintiff in this cause is an adult and a resident of Frederick County, Mary-
land, that the defendants in this cause are all adults and are all residents of Frederick
County, Maryland, with the exception of Margaret H. Stouch and Roy M. H. Stouch her
husband who are both residents of the City of York in the State of Pennsylvania,
2nd That Lucretia L. Hauer who was the surviving widow of one George W. Hauer who died in
said Frederick County, some time in the year 1875, did intestate at said County September
3rd, A.D. 1896 seized and possessed at the time of her death of a house and lot in
the City of Frederick, State of Maryland, being the same property mentioned and described
in a deed from Philip M. Englebright, Executor of the last will and testament of Michael
Bromett dec'd of said County, deceased of date January 17th A.D. and recorded among the Land
Records of said Frederick County Maryland in Liber J. C. No. 6 folio 572 etc all of which well ap-
pear by reference to a certified copy of said deed filed as Exhibit No. 1 to this bill of complaint
and which together with all other exhibits which the plaintiff has and may hereafter file
is prayed may be taken and considered as part of this bill,
3rd That the said Lucretia L. Hauer never married again after the death of her said husband
the said George W. Hauer who died as before recited some time in the year 1875;
4th That the said Lucretia L. Hauer left surviving her the following children who are her heirs at law
