 and Litus G. Day do grant unto Delilah Tabler all that part or parcel of land lying and
 being in Frederick County and State of Maryland, being part of two tracts of land called
 "Resurvey on Millcat Spring" and "Resurvey on Discovery" beginning for the same at a stone
 planted on the South-East side of the county road leading from Hyattstown to Lemansas
