she did give, devise and bequeath to Charles H. Ross, the farm situated near Gaithersburg Montgomery County, Maryland upon which her Cousin Thomas Marshall then resided, and also the sum of fifteen thousand dollars in trust, to permit the said Thomas Marshall to reside on the said farm, and to receive the rents issues and profits of the same for and during his life and also upon the trust, to invest the said sum of fifteen thousand dollars in some safe security or securities with power from time to time to reinvest the same, and to pay the annual income thereof to the said Thomas Marshall for and during his life, and after the death of the said Thomas Marshall said testatrix did give and devise said farm to his sons Thomas Marshall and August Dyer Marshall at a valuation of four thousand four hundred dollars, and the said sum of fifteen thousand dollars, said testatrix did will and direct shall be equally divided between his three daughters by his second wife, and in the event of any or either of said three daughters dying, leaving child or children living at the time of distribution, then the share or portion of such daughter so dying was given and bequeathed to her or their issue or children then living to be equally divided, and in case any or either of same, shall die without leaving child or children or descendants then living, then said testatrix did will and direct that the said share or portion shall go to and be equally divided between the survivor or survivors of said daughter, <sup>And by another</sup> <sup>any legatee</sup> of said will. Said testatrix authorized and empowered, in said will or any trustee named in said will on behalf of their respective trusts to have the privilege of electing any of the securities belonging to her estate at their appraised value and of selecting any of her <sup>land</sup> <sup>interests</sup> <sup>at their appraised value</sup> of their actual value, the actual value to be ascertained by some persons familiar with the values of such properties in full or in part of the respective legacies by said will bequeathed to them. And did direct her Executors namely Charles H. Ross, and George Johnson upon selection being made by said legatee or any of them to deliver over such securities as pass by delivery and transfer by proper methods of transfer such securities or properties as may require the same, and to convey such ground rents as may be selected, by deeds properly executed and acknowledged so as to carry out the intention of said testatrix will, all of which will appear by reference to a Certified Copy of Extracts of said will of said Ann P. Marshall, herewith exhibited and marked Exhibit "1" which your petitioner prays may be taken with all other exhibits hereafter produced as part of this his petition.
