A Copy of said account, itemized, and Copies of the title papers to said real estate being filed as part of the Bill that the personal estate of said Sarah A. Snyder is wholly insufficient for the payment of her debts, and is of such small value that no letters of Administration have been taken ^{out} upon her estate; that the said Sarah A. Snyder left surviving her, as her heirs at law the following Nieces and nephews, residents of the State Maryland to-wit: Jennie Filler, now the wife of Daniel Filler, Della Taylor, the wife of Complainant C. Pierce Snyder, whose wife's name is Mallic Snyder, G. Albert Dierbeck, whose wife's name is Fella Dierbeck, whose wife's name is Fella Dierbeck, and Ida Litchell now the wife of George W. Litchell and the following Nieces and nephews, now residents of the State of Maryland: Anna Krick, now the wife of A. M. Krick, Samuel Snyder, George A. Snyder, whose wife's name is Leda Snyder, William J. Snyder, John R. Snyder, Charles E. Snyder, whose wife's name is Marcetta Snyder, Jacob H. Snyder, whose wife's name is Mary J. Snyder, Mary M. Snyder Minnie E. Van Wagner, whose husband's name is Vincent A. Van Wagner, Ida M. Snyder, James J. Snyder, whose wife's name is Nellie Snyder, J. Harry Snyder, whose wife's name is - Snyder Myra Skinner, now the wife of Arthur Skinner, Katie Snyder, Robert Snyder Mary Elizabeth Winters, now the wife of Howard Winters and Jacob Snyder, all of whom are adults except the said Ida M. Snyder, who is an infant, that there are also living the following grand-nieces and grand-nephews of said Sarah A. Snyder, they being grand-children of George Snyder, a deceased brother, to-wit: Amy Elway, Edward Elway, whose wife's name is Eva Elway, Adults, and Robert Elway, and Harry Elway, infants, and Mary Mc. Krotky, an infant, and Emma McKrotky, now the wife of John L. Dumm, adults but whom, Complainant, alleges, have no interest in the real estate of which said Sarah A. Snyder died seized and possessed.
